Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title and then they cannot enter the Instinct Test. Any dog completing a division may move up in the next trial. This is up to the handler and not required for 30 days.

**B DIVISIONS:** If you have titled in Master you have to enter Master B. If you enter any B division, you must stay in that division for the entire event. For more descriptions of B divisions please see the rulebook.

#### Driving Directions:

FOOD SERVICE WILL BE AVAILABLE AT THE TRIAL SITE. ROUTES TO TRIAL South of Metro Denver and easily accessible from I-25. Exit I-25 at Castle Rock exit 181 (Plum Creek Parkway) – turn East. Follow Plum Creek Parkway approximately 1 mile and turn left at the light onto Fairgrounds Drive. Follow the road a few hundred yards to the Indoor Arena located to the North of the main building - the Events Center. Use Gate E to enter the area. Parking will be on the South and East sides of the Indoor Arena Only. [A horse auction on Saturday will likely use all of the parking North of the Indoor Arena.] AREA

### **Collars and Leads- IMPORTANT**

Approved collars include flat snap or buckle collars of solid construction and leather or nylon leads. Slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed. Dogs MUST run "naked," without a collar/harness. **NO** flexi-leads allowed.

### **Bitches in season**

Bitches in season (BIS) MAY compete at Barn Hunt trial. They will be run at the end of each class. **Bitches in season must wear pants**

### **Height Divisions**

- Dogs 13" and under, small
- Dogs 13.1 to 18", medium
- Dogs over 18", large

### **Awards**

Each division and height group will have awards through fourth place based on the elapsed time of marking the rat tube. Title rosettes will be awarded to dogs finishing a title. Fastest Dog in each division will receive a special prize and rosette.
